PAYMENT AGREEMENT

I AGREE TO PAY A ONE-TIME REGISTRATION, NON-REFUNDABLE FEE OF \$75.00. I AGREE THAT THE REGISTRATION FEE OF \$75.00 WILL BE PAID IN FULL BEFORE ENROLLMENT AS WELL AS A 2 WEEKS SECURITY DEPOSIT. I AGREE TO PAY A REGISTRATION FEE OF \$75 AND 2 WEEK SECURITY DEPOSIT (2 WEEKS PAYMENT OF SCHEDULED DAYS) IN THE AMOUNT OF \$ TO ENROLL MY CHILD. AS DEFINED IN THE SECURITY DEPOSIT POLICY, MY SECURITY DEPOSIT WILL BE RETURNED IF 2 WEEKS PROPER NOTICE IS GIVEN BEFORE MY CHILD'S LAST DAY IN THE PROGRAM. PROPER NOTICE IS DONE IN WRITING THROUGH MAIL, HIMAMA MESSAGE, OR EMAIL 2 WEEKS BEFORE MY CHILD LEAVES THE PROGRAM. I AGREE PAYMENTS ARE DUE IN FULL ON THE 1ST OF THE MONTH.
